MINUTES OF THE 916TH MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE HALL ON MONDAY 26TH NOVEMBER 2018

18-155 SAFETY PROCEDURES

The Chairman explained the Safety Procedures.

18-156 PUBLIC PARTICIPATION

There were no members of the public present.

18-157 TO RECEIVE AND ACCEPT APOLOGIES FOR ABSENCE

Apologies received and accepted from Cllrs Bastin and Palmer.

18-158 MEMBERS TO DECLARE ANY DISCLOSABLE PECUNIARY AND NON-REGISTERABLE INTERESTS AND ANY GIFTS OR HOSPITALITY OVER £25

18-159 TO CONSIDER REQUESTS FOR DISPENSATIONS FROM MEMBERS

18-160 TO RECEIVE AND APPROVE THE MINUTES OF THE COUNCIL MEETING HELD ON 29[™] OCTOBER 2018 AND THE CHAIRMAN TO SIGN THEM

It was proposed by Cllr Geraty and seconded by Cllr Fairbank and:

RESOLVED that the minutes of the Council Meeting held on the 29th October 2018 are received and approved.

On a vote being taken this was approved unanimously. The Chairman then signed them.

The Clerk reported that:-

18-163 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL DIVISIONAL MEMBER

Cllr Bastin was not present at the meeting – the following matters were reported on his behalf by the Chairman and Clerk.

- Feedback given regarding recent issue with Barratt Homes being not aware that Union Park is mostly in Budock Parish.
- No meeting has yet been held with the Site Manager for the Taylor Wimpey development.
- Complaints have been received regarding a 'phantom nappy thrower' in Budock village. Used nappies have been dumped around the village and in the river.
- Thanks given to the organisers of Feast Night.
- Cornwall Council are proposing a Council Tax increase of 3.99%, 2% of which will be ring fenced for Adult Social Care.
- Cornwall Council now have £30 million (£10 million for the next 3 years) to improve road surfaces.
- Changes are on the horizon for the way planning will be delivered; with set officers for each area to allow for a strategic planning overview.

18-164 TO RECEIVE A NEIGHBOURHOOD PLAN UPDATE AND TO CONSIDER ANY ACTIONS REQUIRED

Cllr Heritage reported the following:-

- Last meeting was on 12th November and the next one is the 3rd December.
- The Housing Strategy has now been largely completed by a member of the group and handed over to Cllr Heritage for final drafting.
- A meeting is taking place in the next week with Cornwall Council's NDP team which Cllr Heritage will attend.
- The Landscape Character Assessments are now on the NDP website.
- Liaison has taken place with the Chairman of Chacewater NDP group and information exchanged.
- The budgeted sum proposed for the 2019/20 Financial Year should be ample to cover expenses.

The Chairman thanked Cllr Heritage for all his efforts in Chairing the NDP Steering Group.

18-165 TO CONSIDER AND APPROVE A SECTION 133 GRANT FOR REPLACEMENT NOTICEBOARDS FOR THE EXTERIOR WALL OF BUDOCK VILLAGE HALL

After discussion and some clarification it was proposed by Cllr Geraty and seconded by Cllr Hart and:

RESOLVED that the Section 133 Grant be approved for Budock Village Hall.

On a vote being taken this was approved by majority vote.

Cllr Bownas requested that it be noted in the Minutes that he voted against this.

18-166 TO CONSIDER AND RESOLVE THE OPTION OF STATIC OR MOBILE SPEED VISORS

Considerable discussion took place on this. Cllr Bownas fed back to the meeting all the information he has gathered regarding mobile speed visors including costs and procedures followed by other councils for moving them. Information obtained from Viv Bidgood, Highways & Environment Manager was also shown. Each Councillor present expressed their thoughts on both options.

It was then proposed by Cllr Hennell and seconded by Cllr Bownas and:-

RESOLVED that £5000 be allocated for the purchase of mobile units within the current financial year; then a review will take place in one year to consider future options.

On a vote being taken this was approved by majority vote.

18-167 TO FURTHER CONSIDER THE PURCHASE OF REPLACEMENT SEATS WITHIN THE PARISH

After discussion and considering information, and pictures, of further seats it was proposed by Cllr Hart and seconded by Cllr Fairbank and:-

RESOLVED to purchase two Glasdon Phoenix seats within this current financial year.

On a vote being taken this was approved by majority vote with one abstention.

18-168 TO SET THE PRECEPT UPON CORNWALL COUNCIL FOR THE FISCAL YEAR 2019/20

The proposed 2019/20 budget proposals were considered. An amendment was made to the document to take account of the resolution in Minute 18-166 to opt for mobile speed visors this year.

It was proposed by Cllr Hennell and seconded by Cllr Hart and:

RESOLVED that a precept of £21,350.00 is set upon Cornwall Council for the fiscal year 2019/20.

On a vote being taken this was unanimously agreed.

18-169 TO CONSIDER STREET NAMES FOR THE EVE PARC DEVELOPMENT

After discussion it was proposed by Cllr Fairbank and seconded by Cllr Bennett and:-

RESOLVED that the suggested names of Bickland View, College Close and Kergilliack Walk as street names are put forward to Persimmon.

On a vote being taken this was unanimously agreed.

i) PA18/10008 – Various works to different trees – Kalugra, Penwarne – Mrs Randlesome After discussion it was proposed by Cllr Hart and seconded by Cllr Heritage and:-

RESOLVED that the following Comment be submitted:-"Having noted the Tree Officer's comments, Budock Parish Council has no objection to this application."

On a vote being taken this was agreed unanimously.

ii) PA18/07891 – [Amended plans] Replace the existing ageing chalet building with a more substantial two bedroom timber frame construction occupying the same footprint of the existing chalet/decking structure, built to a standard more suitable to all year round residence – St Mawes, Pendra Loweth – Mr

After considering the amended plans it was proposed by Cllr Hennell and seconded by Cllr Bownas and:-

RESOLVED that the following Comment be submitted:- "Having now seen more detailed plans, Budock Parish Council has further considered this application and has no objection to it."

On a vote being taken this was agreed by majority vote.

iii) PA18/10487 – New single storey side extension with internal alterations – amendment to previously approved scheme PA17/08559 – 20, Vicarage Close, Budock Water – Mr & Mrs Cooksey

After considering the proposed amendments it was proposed by Cllr Geraty and seconded by Cllr Bownas and:-

RESOLVED that the following Comment be submitted:- "Budock Parish Council has no objection to this application."

On a vote being taken this was unanimously agreed.

- i. **Footpaths & Rights of Way –** The Clerk reported that all issues raised at the last meeting have been reported to Cornwall Council, plus problems with a dangerous stile at Penwarne. Two further broken footpath signs were reported at the meeting.
