MINUTES OF THE 901ST MEETING OF BUDOCK PARISH COUNCIL HELD AT BUDOCK VILLAGE HALL ON MONDAY 24TH APRIL 2017

17-01 SAFETY PROCEDURES

The Chairman explained the safety procedures.

17-02 TO RECEIVE AND ACCEPT APOLOGIES FOR ABSENCE

Apologies received and accepted from Cllr Gibson – unable to attend due to work commitments.

17-03 MEMBERS TO DECLARE ANY DISCLOSABLE PECUNIARY AND NON REGISTERABLE INTERESTS AND ANY GIFTS OR HOSPITALITY OVER £25

Cllr Palmer declared an interest in agenda item 18iii. He will leave the room for this item.

Cllr Bastin joined the meeting at 7.32pm.

17-04 TO CONSIDER REQUESTS FOR DISPENSATIONS FROM MEMBERS

The ongoing dispensations held by Cllrs Hart and Fairbank will be effective in agenda item 18ii.

17-05 TO RECEIVE AND APPROVE THE MINUTES OF THE COUNCIL MEETING HELD ON 27TH MARCH 2017 AND THE CHAIRMAN TO SIGN THEM

It was proposed by Cllr Geraty and seconded by Cllr Bennett and:

RESOLVED that the minutes of the Council Meeting held on the 27th March 2017 are received and approved.

On a vote being taken this was unanimously agreed.

17-06 TO REPORT MATTERS ARISING FROM THE MINUTES NOT ON THE AGENDA (for information only)

The Clerk reported that following on from the presentation made to the Parish Council at the last meeting, Wild Eyedeer are holding a Public Consultation on Thursday 27th April between 1pm and 7pm regarding their future plans.

17-07 TO RECEIVE ANY POLICE UPDATES

No updates have been received from PCSO Fuller. The latest information on the Police website shows one crime occurring in the parish in February. This was in the 'Anti-Social Behaviour' category at or near School Lane, and is shown as being still under investigation. (*Details, case timelines and current status are not provided for anti-social behaviour*).

17-08 PUBLIC PARTICIPATION / COMMENTS ON ITEMS ON THE AGENDA

There were no members of the public present.

17-09 TO RECEIVE A NEIGHBOURHOOD PLAN UPDATE AND TO CONSIDER ANY ACTIONS REQUIRED

Cllr Heritage reported that the Steering Group met on 4^{th} April. There were seven attendees and one apology. Two more people have come forward who would like to be involved. The main outcome of the meeting was the agreement that the whole of Budock Parish be allocated as the 'Designated Area'. Several members have also showed an interest in getting involved with specific aspects of the plan's development.

It was proposed by Cllr Heritage and seconded by Cllr Bennett and:

RESOLVED that the Designated Area be the whole of Budock Parish and that the Clerk completes and submits the Designation Statement to the Neighbourhood Planning Team at Cornwall Council.

On a vote being taken this was unanimously agreed.

17-10 TO CONSIDER LOCAL CONCERNS REGARDING THE DETERIORATING STATE OF TREVERVA CHAPEL

The Clerk confirmed that the Chapel is still part of the property of Falmouth and Gwennap Methodist Circuit. The reason the last sale fell through was because of drainage issues. The Circuit is actively engaged in trying to resolve the issue prior to advertising the property for sale again.

It was noted that some of the ground floor windows are in a poor state of repair, which could lead to there being a risk of the building being broken in to. Also there is evidence that the two outside toilets are being used and some of the metalwork has been removed from the archway and is now lying on the ground.

It was proposed by Cllr Bennett and seconded by Cllr Hennell and:

RESOLVED that the Clerk writes to both English Heritage and the owners of the chapel, pointing out the Council's concerns over the deteriorating state of the chapel and asking for reassurances that they will prevent any further deterioration.

On a vote being taken this was agreed with 1 abstention.

17-11 TO CONSIDER AND APPROVE THE END OF YEAR GOVERNANCE STATEMENTS FOR THE YEAR ENDING 31ST MARCH 2017

All Councillors had been sent a copy of this prior to the meeting. The Statements were discussed and the Clerk completed the form as agreed by all.

It was proposed by Cllr Fairbank and seconded by Cllr Hennell and:

RESOLVED that the Governance Statements as agreed are approved and signed by the Clerk and Chairman.

On a vote being taken this was unanimously agreed.

17-12 TO RECEIVE AND APPROVE THE END OF YEAR ACCOUNTING STATEMENTS FOR THE YEAR ENDING 31ST MARCH 2017

All Councillors had been sent a copy prior to the meeting.

It was proposed by Cllr Hart and seconded by Cllr Fairbank and:

RESOLVED that the End of Year Accounting Statements are approved as correct.

On a vote being taken this was unanimously agreed.

17-13. TO CONSIDER AND APPROVE THE COUNCIL'S 'STATEMENT OF INTERNAL CONTROL' FOR THE YEAR 2016/17 All Councillors had been sent a copy of this prior to the meeting.

It was proposed by Cllr Geraty and seconded by Cllr Heritage and:

RESOLVED that the Council's 'Statement of Internal Control' for the year 2016/17 be approved.

On a vote being taken this was unanimously agreed.

17-14. TO RECEIVE THE INTERNAL AUDIT REPORT 2016-17

Hudson Accounting carried out the Internal Audit on April 12th. The subsequent Report had been distributed to all Councillors prior to the meeting. The two recommendations were discussed.

It was proposed by Cllr Fairbank and seconded by Cllr Hart and:

RESOLVED that the report be accepted but to note that the recommendation for a Purchase Order Book to be kept was "inappropriate".

On a vote being taken this was unanimously agreed.

17-15 TO RECEIVE A REPORT FROM THE CORNWALL COUNCIL DISTRICT MEMBER

Cllr Bastin reported on the following:-

- There has recently been a Peer Review of the Planning System. In future the Strategic Planning Committee will consist of 15 members selected from right across the county.
- In future if a District Councillor puts forward a case for one of the parishes or wards they represent at a Strategic Planning Meeting, then they will not be able to vote on the application. Also there will no longer be the facility to ask the speaker questions after they have put their case.
