### 17-P28 TO CONSIDER PLANNING APPLICATIONS RECEIVED FROM CORNWALL COUNCIL

i) PA17/10902 – Variation of Condition 2 of application W2/PA06/00740/F (Erection of an extension and conservatory extension to dwelling) – Belle Vista, Hillhead Road, Kergilliack – Mr & Mrs Paffett

After discussion it was proposed by Cllr Hart and seconded by Cllr Mrs Clark and:

**RESOLVED** that the following Comment be submitted:- 'Budock Parish Council has no objection to this application'.

On a vote being taken this was unanimously agreed.

ii) PA17/11529 – Proposed demolition of existing Utility Extension. Proposed new Single Storey Extension to North West and South West, and Ground Floor internal alterations to existing dwelling. New bay window to NE. Windows replaced with aluminium on SE elevation – 1, Churchtown, Budock Water - Mr & Mrs Kirby

After considerable discussion where the poor labelling of the plans was noted, and will be followed up, it was proposed by Cllr Hennell and seconded by Cllr Fairbank and:

iii) PA17/11782 – Felling of Common Beech tree – Penjerrick House, Penjerrick, Budock Water – Mrs R Morin
After discussion it was proposed by Cllr Fairbank and seconded by Cllr Mrs Clark and:

**RESOLVED** that the following Comment be submitted: 'Budock Parish Council supports this application in line with Objective Tree Consultancy's comments; especially emphasising the need to replant'.

On a vote being taken this was agreed with one abstention.

### iv) PA17/11786 - Proposed alterations - Meadowside, Treverva - Ms K Davies

After discussion where it was noted that the site plan and boundaries were incorrect it was proposed by Cllr Hennell and seconded by Cllr Bennett and:

**RESOLVED** that the following Comment be submitted:- 'Budock Parish Council has no objection in principle to this application but note that the Site Plan is inaccurate and incorrect, and the boundary is not clear.'

On a vote being taken this was unanimously agreed.
