'Budock Parish Council feel that the proposed pruning of the beech trees would significantly detract from the public visual amenity value of this cohesive group and would have a negative impact upon their physiological condition as well as their contribution to local landscape character. Whereas The proposed coppicing of the sycamore T01483 is non-controversial and can be supported; this work is in line with previous consents to coppice sycamores in this area.'

Budock Village Hall – The village hall had their monthly meeting on 12th February 2024. The Folk Night on 23rd January. "The Stamp&Go" group had kindly agreed to donate their fee to the Village Hall.

The impending planning permission to have the roof of the hall replaced was discussed to ensure that timings were efficient. It was thought that this may be done through a separate grant fund application to the refurbishment of the rest of the hall due to its urgency. A public consultation is being organised for 15th March when plans for the hall will be available to view to the public and the architects would be present to answer any questions.

The issue of safeguarding was discussed with regards to the users of the hall and with an eye on applying for grants. Matt agreed to be the safeguarding lead and propose a way forward at the next meeting. Date of next meeting - 14th March 2024 **Treverva Village Hall** – Nothing to report other than bookings are coming in.

Playing Field – The final issues have been resolved with the 3 grant funders regarding the refurbishment of the Playing Fields. We are now awaiting the weather to improve so that the contractors can make a start without churning up the field. We have the refurbished see-saw to install too which was kindly repaired by Pendennis Shipyard.

Our next event is on April 13th and will likely to be a Treasure Hunt similar to successful events we've held previously. We are still in the process of "hand-over" between the outgoing and incoming treasurer which is hindered by our very antiquated bank account. As a charity account it is troublesome to change and delaying some of the accounting issues that need resolving. As Chair of the Playing Field Association, I have also been able to input into the process of refurbishment of the hall which is moving along at pace.
