- 1. Application PA25/07265 Proposal** Permission in principal for a residential development of up to 4 dwellings **Location** Land At Church View Lamanva Penryn Cornwall **Grid Ref** 176462 / 31804 (**Case Officer - Mark Webb**)
After discussion, the following was agreed.

It was proposed by Cllr Chatterjee I and seconded by Cllr Davison and:

RESOLVED that the following comment be submitted: - Budock Parish Council consider this Application in contravention of Policy 7 of the Cornwall Local Plan and Policy H1 of Budock Parish Neighbourhood Development Plan in that it lies outside of the Defined Settlement Boundary for Lamanva and Treverva, is not affordable housing and breaches the new build quota for the area.

The Development boundary runs up the drive to the main residence Church View and there is a current grant of permission for an additional residence in a triangle of grass to the North West of this access drive PA 23/01987 - a permission which effectively blocked off further allocations for the combined settlements of Lamanva and Treverva until 2030 as defined in the Budock Neighbourhood Plan. This settlement boundary was very much a factor in the informal advice given regarding PA21/02886/PREAPP |Pre application advice for Construction of 5 dwellings on former plant hire & bus yard/depot. Mann Plant Hire Little Lamanva Lamanva Penryn Cornwall TR10 9BJ. That application was closed and a fresh submission for 4 houses only followed and was approved.

And this summer we also note these were considerations given weight in nearby PA25/04765.

Where we find the following comment by the Planning Officer for the caravans at nearby Tresooth.

"Policy 7 of the Cornwall Local Plan (CLP) and Policy H1 of the Budock Neighbourhood Development Plan (NDP) establish a clear spatial strategy that directs new housing to within defined development boundaries and strictly controls residential development in the open countryside. The application site lies outside any such boundary, and the proposal does not meet any of the specific exceptions for rural housing outlined in CLP Policy 7 (such as agricultural workers' dwellings or the conversion of historic buildings). Therefore, the proposal is in clear conflict with the adopted spatial policies of the development plan." OFFICER REPORT – DELEGATED

All-in-all this PIP is not in accordance with para 55 of the NPPF 2024.

Councillor Hume expressed to the meeting she is unhappy about the procedures used by Cornwall Council when road closers orders are issued.

After discussions it was concluded that the signage could be improved and Cllr Saunby will speak to Cornwall Council about this on our behalf. Unfortunately, there is nothing further we can do to improve the issues of road closures.

25-126 TO CONSIDER CYBER SECURITY AND DEDICATED LAPTOPS FOR COUNCILLORS

Councillor Hume requested the consideration of every councillor been provided with a dedicated council laptop.

This had been brought before the council in April 2024, and it was voted that the capital cost and ongoing costs to supply 10 computers to all members was not an efficient way to spend the precept.

After discussion it was agreed that Councillor Chatterjee will investigate and report back with a number of quotes from agreed suppliers for providing each councillor with a dedicated laptop for the sole use of the parish council.

The costs for software and set up costs will be discussed with a IT consultant and brought to the next meeting along with quotes for the laptops for discussion.

It was proposed by Cllr Bastin and seconded by Cllr Burnett and: -

RESOLVED that the Cllr Chatterjee will use agreed IT suppliers and update at the next meeting with a number of quotes for computers, software, set up costs and ongoing maintenance for each councillor.
