2024/25-4 TO RECEIVE THE CHAIRMAN'S REPORT 2024 – 2025

The outgoing Chairman gave his report

It is with regret that this will be my last report. I have been a Parish Councillor for 25 years and now feel that it is time for a rest. There have been ups and downs in Council membership over the last twelve months. We have however finished the year with a Council of 8 members, these being residents of the parish who are prepared to give up spare time to serve their local community. After the uncontested election the new Council will be looking to co-opt six Councillors to bring the Council up to full strength.

In past years I have commented on the great concerns we as a Council have had regarding building in the Parish as ever we have kept a very close watch on property developers so that we may protect the rural nature of our Parish.

Although it might not seem like it the speed visor that the Parish Council arranged to be installed on the hill leading in to the village continues to reduce the number of speeding motorists. The message continues to slowly get through.

In order to make the Council more accessible to our parishioners we have held a number of surgeries at both Treverra and Budoock and these have helped make us aware of parishioner's needs and opinions. These may well continue during the forthcoming year

As ever we have continued with arranging the weed control on roadside edges and verges together with the routine cutting and maintenance of the major footpaths within the parish. These footpaths are an essential part of the heritage and assets of the parish and are enjoyed by locals and visitors alike.

If anyone reading this report feels that they can spare time to assist at the Playing Field or either of the Halls then please do so as these assets are looked after by a handful of volunteers some of whom have been doing so for many years. Again this year I have received phenomenal support from our Clerk, Tracy Hladkij, and forbearance from my fellow Councillors and I thank them all.
