Kergilliack progress now being made as Barratts enter discussions with landowners resetting the road back into their gardens.

This would mean the road would not have to be reduced in width.

Development Plan Document out for discussion — my feeling it does not go far enough to protect grade 3a and above agricultural land from development. This is a threat to long term food security. Also, Area of Natural Outstanding Beauty needs stronger protection.

Community Network Panel and Climate Action Group meeting delayed until June because of elections and PURDA

PURDA starts on the 21st March — guidelines sent to Councils on acceptable protocols and behaviour.

Budock Parish Council now considered to be under the Truro Falmouth area for election purposes.

This is because the Cornwall Councillor will in future represent both Budock and the Trescobeas ward of Falmouth.
